Town of Oro Valley receives \$685K for Honeybee Wash Bridge repairs

We're excited to announce the award of \$685,000 in Congressionally Directed Spending for the Honeybee Wash Bridge Deck Repair, focused on Rancho Vistoso Boulevard. This funding ensures the bridge remains safe for residents and visitors, with work expected to begin in Spring 2025. We are anticipating additional Congressionally Directed Spending in FY 24/25 for other projects, thanks to the efforts of Arizona Rep. Juan Ciscomani, and Senators Mark Kelly and Kyrsten Sinema.

Levee augmentation project in the CDO Wash

The Pima County Regional Flood Control District, TOV, and KE&G teams are making great progress, with completion expected by December. This project will enhance flood protection and improve The Loop Trail around OV with repaying and restriping for a smoother ride.

Vistoso Trails Nature Preserve update

The Town has selected Kimley-Horn and Associates, Inc., for the next phase of the Vistoso Trails Nature Preserve restoration project. Staff is also engaging with key stakeholders to bring concepts to Council in September.

Fully staffed OVPD Telecommunications

The Police Communications Division is now fully staffed for the first time since January 2019. "This is a positive for morale and overall wellness," said OVPD Comm Center Manager Michelle DeVault. Fully staffing the center will allow team members more time off and reduce overtime costs.

PW Facilities - Building Maintenance




PW Transit - Number of Passenger Trips Provided & Passengers per Hour





Parks and Recreation - Field and Ramada Reservations







Goal is to add 300 new registered users to WaterSmart per year. 25 new registered users per month will achieve the goal.






TM Procurement - Total Time Spent Processing Fraudulent pCard Activity



POLICE DEPARTMENT

CASES AND STATISTICS

Case 1

July 23, Officer Topar was contacting a vehicle reported as suspicious. While contacting the vehicle, the officer observed a rifle in the vehicle. He asked the occupant to exit the vehicle for officer safety and the driver fled. In the process of fleeing, the driver ran over the foot/leg of Officer Topar. OVPD detectives are investigating and attempting to locate the driver/suspect.

Case 2

July 22, OVPD was dispatched to a domestic violence incident involving a firearm. During an argument, a 91-year-old male pulled a gun and pointed it at family members. OVPD officers were able to safely extract all family members from the residence and made repeated attempts to communicate with the suspect. Eventually, the suspect was talked into exiting the residence without the firearm and was taken into custody with no incidents. SWAT had been called out but was cancelled due to the safe resolution of the incident prior to their arrival.

Case 3

OVPD Officers were dispatched to a report of a multiple vehicle injury collision with a possible ejection from one of the vehicles. Upon arrival, officers found a six-vehicle collision, with several people injured. There was a total of five people transported to the hospital, some with serious but non-life-threatening injuries. The causing driver left the hospital prior to arrival of officers. Officers had developed enough probable cause to obtain a warrant for hospital records containing the blood results taken by hospital staff. The cause of the crash was driver impairment, and the driver is expected to be charged with approximately 19 felony charges.



STATISTICS

Single Family Residential (SFR) Activity – 11 new Single Family Residential permits were issued during the month of July compared to 19 SFR permits issued in June. Year to date, 112 SFR permits have been issued since the beginning of the year compared to 68 issued during the same period in 2023.

Permitting Activity – 174 total permits were issued during the month of July compared to 157 permits issued in June. Year to date, 1,257 total permits have been issued since the beginning of the year compared to 1,442 issued during the same period in 2023.

Economic Development


- Primary Employer Development
 - Economic Development staff continue to work the PICOR to identify potential leads for available lots in Innovation Park. Staff are meeting monthly to discuss leads generated through the Town's subscription to GazelleAI and discuss strategies with PICOR regarding how best to make contact and initiate recruiting strategies.
 - Staff received one lead from ACA but was unable to provide any potential site for consideration since the project requirements included existing 30,000 SF office with the ability to ramp up to 125,000 SF within 10 years, in proximity to other semiconductor chip production facilities.

Tourism

- Group booking efforts
 - Staff provided local resorts the following prospects:
 - Hosting potential jujitsu tournaments on site which could result in 50 to 100 room nights for three nights for 2025. There are several possible tournaments to bid.
- Sports Event Requests for Proposal (RFPs)
 - Staff responded to one RFP to host the Quadballfest 2025.
 - Staff continues to work on a Pro Pickleball Tournament event to be hosted at the OV Community Center.



PLANNING PROJECT HIGHLIGHTS

Registration for Oro Valley's 27th Community Academy is now open. This year's academy is focused on helping residents get ready to work on the community's next 10-year action plan, known as OV's Path Forward. Residents will learn about how OV currently manages growth and traffic, maintains its water supply and public safety, conserves the environment, and more. Classes will take place twice a week in October from 6-8 p.m. at Town Hall. Details are available online. Visit orovalleyaz.gov and search COMMUNITY ACADEMY. Registration closes on September 27.



Staff from Planning and Innovation & Technology have partnered with the Parks & Recreation Department to kick off efforts on a Trails Master Plan for the Town. The Planning team will serve as the project manager and will utilize a consultant to provide technical assistance collecting data and putting the plan together. Key plan elements will include public outreach, evaluating existing easements, connectivity analysis to parks and destinations, and identify future potential trails and improvements. The project is targeted to be completed by next year.

PUBLIC WORKS

BOND PROJECTS

Naranja Park Expansion Project

Staff is still working with the contractor cleaning up splash pad and drainage issues around the site.

GENERAL PROJECTS UPDATES

Community and Recreation Center Elevator

Construction of the exterior retaining wall footing is in progress. Progress inside continues. The elevator pit excavation and cement pour has been completed. Placement of elevator shaft structural steel is installed. There is exterior concrete work proceeding with concrete curbs and sidewalks being placed. This project is back to full steam ahead.





Oro Valley Town Court Expansion

Construction continues on schedule, though three weeks were added to the contract due to an IT infrastructure amendment to the plans. The trees and roots on the west side of the facility have been removed. An electrical circuit that supports the flagpole lighting was broken during the excavation. As the original installation was not to code, it may not be repaired in place. Alternate methods of powering the lights are being considered.

Valley Vista Subsidence Issues

Current mitigation and construction activities are limited to the Pima County sanitary sewer repairs. A manhole and some of the gravity piping mains subsided and shifted. Pima County is currently correcting the infrastructure. They anticipated that they would be finished by the end of July. However, Town staff received notice from Pima County Wastewater that recent storms impacted their current work.

This could have impacts to the date for the Town's open house to inform neighborhood residents of the upcoming street replacements. The reason that we are waiting until Pima County is completely finished is that we want to make sure there are no unexpected discoveries from their work that could impact both their finishing or Pulte moving forward with the street correction measures. Hence, we are not setting the open house date yet.

Stormwater Utility

Pima County Cañada Del Oro (CDO) Wash Levee Augmentation Project

The Pima County Regional Flood Control District (PC RFCD) progresses with their Cañada Del Oro (CDO) Levee Augmentation project through the Town. Phase 1 of 7 has been completed downstream of La Cañada Drive, and work continues on phases 2 through 6. Expected completion of the project is Fall 2024. The project remains on schedule (photos below).

The Town continues to coordinate with our partners at Pima County for communications with residents. The Loop trail impact reminders continue to be pushed by PC RFCD and County Communications in coordination with the Town to keep the residents and

users up to date.





Stormwater Utility Staff Certification

Stormwater Utility Inspector Jane Hutchins has completed her certification training and testing through the State of Arizona Department of Transportation (ADOT) for Erosion Control Coordination (right). Beyond staying up to date with state-level standards and compliance requirements for stormwater pollution prevention, this certification allows the Stormwater Utility to inspect and submit monitoring reports to the Arizona Department of Environmental Quality (ADEQ) for construction projects.



FEMA Flood Insurance Rate Map Revisions within Oro Valley

The Department of Homeland Security's Federal Emergency Management Agency (FEMA) is in the process of validating a draft Flood Insurance Rate Map (FIRM) database for the following flood hazard mapping studies: Sabino & Bear Creek, Oro Valley, Southern Santa Cruz, and Rillito Watershed Base Level Engineering (BLE). Completing the draft FIRM database is a milestone that marks the completion of the collection and analysis of the project's initial engineering data. This data provides the best available calculations where flood water will collect and flow based on current conditions.

The FIRM for a community depicts the floodplain, the area that has been determined to be subject to a 1% or greater chance of flooding in any given year (over 100 years). The FIRM determines flood insurance rates and to helps the community with floodplain management. FEMA is proposing modifications to the floodplain boundaries on behalf of Pima County and the Town of Oro Valley, which will revise FIRM 04019C along the La Cholla and Mutterer/Pusch/Rooney Washes. FEMA is proposing to revise the FIRM to reflect constructed channel improvements performed by the Town of Oro Valley and Pima County.

The Town will send a letter out to all affected property owners outlining the changes, so that they are fully informed and not caught off-guard, particularly if they will now need to obtain flood insurance.

Street and Drainage Operations

- Street Crews have completed sidewalk repairs in the Canyon Shadows (1-125) Neighborhood and are now working to complete repairs in JDK Park.
- Crack Sealing (cold-applied polymer) continues in Rancho Vistoso Neighborhood, 10 parcel S, U, and V (1-215) subdivisions.
- Street Crews have also been busy with sediment removal in various areas due to monsoon storm activity.
- Townwide Right-of-Way landscape maintenance continues at various locations by Town staff, ADC crew and contractor crew as vegetation continues to be extremely active due to the significantly wet start to 2024; and now with start of the monsoon season with additional wind damage storm cleanup in various areas.

PARKS & RECREATION

ADMINISTRATION

The end of July marks the end of summer and the end of our summer camp programs for the Parks and Recreation Department. Staff held summer camp at three different locations throughout the Town.

The department also hosted a heavily attended 4th of July event at JDK Park (*photo right*). This year there were more than 10,000 people in attendance. What a great turnout!



Staff has planned for busy fall to include Friday Night Concerts, Bark in the Park, movies, multiple programs, Fall Break Camp, and our annual HallOVeen Spooktacular.

AQUATIC CENTER (OVAC)

OVAC hosted a Dive-In Movie event on July 13 (Little Mermaid) and the Youth Advisory Council Disco Night on July 27. Both events were well attended with the Dive-In Movie being a sellout!

A local resident from Girl Scout Troop #217 completed her Silver Merit Award project, in which she hosted a booth for a week at OVAC to share information about the importance of skin protection during the summer sun season.

The facility hosted the summer swim league SAAA Championships at OVAC, July 8-11, consisting of 14 teams and approximately 1,700 swimmers from the greater Oro Valley area.

Another incredibly successful Camp SPLASH season finished on July 19 with nine weeks of sold-out sessions.

OVAC was open for limited hours during the July 4th celebration with additional family space available, along with diving boards and slide. 524 individuals took advantage of this opportunity.

Oro Valley Aquatics celebrated July as the nation's official Park and Recreation Month by participating in the "Arizona Lifeguard Challenge 2024" hosted in Avondale, Ariz. The team tied for second at the competition held at the Avondale Aquatic Center.

RECREATION AND CULTURE

July started off with a bang with more than 10,000 people joining together at the 4th of July Celebration event (*photo right*). This event is the largest annual event that the department hosts and this year was extremely successful. The community turn out and staff support made this another memorable event.



Summer programming is beginning to finish up, which will lead into the return of the Fall Concert Series and Movie Series at Steam Pump Ranch.

COMMUNITY AND RECREATION CENTER (CRC)

The CRC is wrapping up another successful season of summer camps! This summer featured several different types of camps hosted at the CRC with nearly 1,400 total registrants (*photo right*). The CRC will welcome back the campers for Fall Break Camp, Oct. 7-11, which opens for registration on Aug. 1.

As summer programming concludes, the CRC will be reintroducing several fitness classes that took a summer hiatus. Staff anticipate the schedule will feature more than 90 weekly fitness classes, which will feature a robust schedule of yoga classes.

The CRC will host another Movie on the Lawn event on Aug. 17, featuring the 2022 animated family/comedy movie, Turning Red. These free community events are hosted on the backside of the facility near the driving range and begin at sunset.



PARK MAINTENANCE

VISTOSO TRAILS NATURE PRESERVE UPDATES

We will continue to share monthly updates on the progress of VTNP.

August 2024 updates:

- Through the Request for Qualifications process, the Town evaluated, selected and entered into a contract with Kimley-Horn and Associates, Inc., to carry out the next phase of the VTNP restoration project per Town Council's direction.
- Staff met with Preserve Vistoso to discuss funding opportunities and identify relevant subject matter expert contacts known to members.
- Staff met with Tucson Audubon to discuss possible funding opportunities they are aware of, as well as discuss Tucson Audubon's expertise and experience, particularly with large-scale restoration projects.
- Staff met onsite to review cart path work completed by the contractor. Some areas were observed that will be addressed by the contractor to ensure consistency.
- Staff met onsite with members of the Department of Forestry and Fire Management to discuss an existing grant that was awarded to the Town for \$20,000 to assist with the removal of invasive species.
- Storm clean-up was completed for any damaged trees causing a safety issue or blocking the trail.
- July 22, a grant application for \$200,000 was submitted to the Department of Forestry and Fire Management for the Invasive Plant Grant to restore disturbed natural areas.
- July 23, a grant application for \$300,000 was submitted to the National Fish and Wildlife Foundation for the Monarch Butterfly and Pollinators Conservation Fund to restore disturbed natural areas and pollinator habitats.

INDIGO GOLF PARTNERS

Golf Rounds for August are budgeted for 5,200 rounds at the 36-hole facility, and Pusch Ridge is budgeted for 0 rounds of golf. We are anticipating 300 rounds of disc golf in the month of August at Pusch Ridge.

As of July 16, we have 376 Full Memberships, which includes 19 Corporate Memberships. The marketing focus for August will continue to focus on full-time, monthly, and corporate memberships.

August events include weekly ladies, men's, and couples competitions. We have seven outside events scheduled for the Overlook/ Sunset Room in August. We will be hosting two Celebration of Life events, Aug. 3 and 10. We will also be hosting the Heirs of the Republic and Republican Women's Club this month.

August projects include – curb and bunker edging, DG #10 tee surround, tree pruning, greens fertilizing, sodding, top-dress greens, verti-cut greens, install drainage on #6 Conquistador.

August maintenance activities include – lake edge clean up, greens fertilization, tree trimming, irrigation audit and gopher control.

CIP—CAPITAL IMPROVEMENT PROGRAM

Northwest Recharge Recovery and Delivery System (NWRRDS): The NWRRDS project is composed of both partnership projects with the Town of Marana and Metro Water, as well as independent projects.

- Independent Projects consist of the following:
 - NWRRDS Booster Station Approximate start: January 2025.
 - NWRRDS transmission pipeline Approximate start: January 2025.
 - NWRRDS D-Zone blending line 100% completed.
 - NWRRDS E-Zone discharge main at Naranja 100% completed.
 - NWRRDS E-Zone discharge main at Tangerine Start date: August 2024.
 - Shannon Road Reservoir & Booster Station 95% complete.
- Partnered Projects consist of the following:
 - Drilling of three NWRRDS recovery wells 100% completed.
 - Well collector pipeline 30% complete.
 - Well equipping Approximate start: November 2024.
 - NWRRDS Reservoir Approximate start: August 2024.



This photo (*right*) shows a section of the nine-miles of the partnered NWRRDS pipeline that will convey recovered Central Arizona Project (CAP) water from the Lower Santa Cruz Replenishment project to the partnered Twin Peaks reservoir.

Big Wash Reservoir Rehabilitation: The Big Wash 250,000-gallon reservoir is one of two reservoirs located near the Oro Valley Marketplace. This reservoir was slated for rehabilitation in fiscal year (FY) 2023/24. Once the reservoir was drained, a closer inspection revealed the need for more extensive rehabilitation work than originally planned, pushing the project into FY 2024/25.

Countryside Central Arizona Project (CAP) water wheeling station upgrade:

This month, the Water Utility completed upgrades to the Countryside CAP water wheeling station. This project increased wheeling capacity at this location from 100 gpm to 300 gpm.






ADMINISTRATION

FINANCE

The Town continues to perform as expected from a Townwide financial perspective. Total Townwide revenues are up \$6,307,803 through May 2024, in comparison to May 2023, primarily due to increased Water Utility billings, Parks and Recreation revenues, and increased investment revenues. Meanwhile, total Townwide expenditures are greater than May 2023 by \$15,193,655. Capital is the primary driver of the increase in spending from the prior year, as it accounts for \$12,716,898 of the \$15,193,655, or 84%. Personnel and O&M also continue to outpace last year's outflows through May. Total estimated Townwide Fund Balances through May 2024 are \$79,888,604, which is about \$9.3 million less than the Town carried into the fiscal year. This reduction in fund balance is primarily a function of the large capital projects being executed and the continued spenddown of ARPA and Parks and Recreation Bond monies.

OV Youth Advisory Council (YAC)

The OV Youth Advisory Council hosted their second Summer Dive-In event of the summer in July, creating an evening filled with excitement and fun for everyone. This time, instead of screening a movie, the event featured a variety of engaging games and music that kept the energy high and spirits soaring. Additionally, the YAC hosted a voter registration booth for those who will be 18 years of age by the General Election.

Emergency Management and Safety

In support of the FY 23/24 - FY 24/25 Council Strategic Plan's objective 6.3.3 (Foster and promote a safe and engaging culture), safety training for all employees currently stands at an 85% completion rate. These important trainings (Fire Prevention, Chemical Safety and Hazard Recognition) are accomplished through a hybrid of online and in-person training platforms in order to meet the specific training needs of the different Town departments. Moving forward, targeted Town staff will take refresher trainings in Bloodborne Pathogens (an OSHA requirement), as well as Defensive Driving, as determined by Town policy and procedure.

OV Mental Health First Aid Training

The Town of Oro Valley's Mental Health First Aid (MHFA) program has officially launched and by the end of September, more than 50 employees will be certified as Mental Health First Aiders. One in five adults live with mental illness and the average person spends a third of their life at work, so promoting mental health literacy and awareness can help us identify when a fellow coworker is struggling and how to realistically support them in a healthy way. MHFA is an evidence-based training that teaches individuals how to identify, understand and respond to signs of mental illness and substance use disorders in both crisis and non-crisis situations. It provides individuals with an action plan and ways of discussing mental health in a non-stigmatizing way.

This program was created in collaboration across the TMO, HR, ELT, and the Wellness Committee.
